TERMS & CONDITIONS

Prospective members are advised of the following terms and conditions of membership.

- Lodging this application does not infer automatic acceptance to membership or provide any assurance about the date membership may be accepted. When this completed form is received by the Club along with the relevant Fee applicable to the category for which membership is sought (or completed Direct Debit Application), you may play without payment of green fees and may play in competition fields to enable you to return five cards for handicap purposes. Should this application be refused, the associated fee will be refunded in full.
- Except in the case of Quarterly membership, fees are payable for the remaining period of the membership year ending on 30 September annually. Payment is required for the full year, and will not be refunded unless approved by the Committee due to exceptional circumstances. If paying via direct debit:
 - payments will continue beyond the term of the membership year unless you give one month's notice before the end of the current membership year, and
 - if you terminate this agreement or cancel the automatic payments in a manner not described in the direct debit agreement you may be liable to Kingston Beach Golf Club for damages of breach of agreement.
- Excepting Quarterly membership, at the start of each membership year, every member is automatically accepted into the same membership category held immediately before that membership year and, except at the written direction of the Board:
 - remains in that category for that playing year, and
 - is liable for the full subscription for that category unless they have resigned, been approved to change membership category, or their category alters due to their age.
- Resignation from membership – you may resign from the Club at any time by advising the Club in writing, noting that membership is committed and fees payable until the end of the membership year on 30 September.
 - Resignations during the membership year will be at the discretion of the Committee; their decision is final and cannot be contested. If resigning membership early due to illness, moving interstate for work or other exceptional circumstances, please lodge your request in writing together with evidence of circumstances (for example, a medical certificate or employer letter). If your early resignation is approved, you will be charged one month's notice along with an administration fee of \$50.
- You may put your membership on suspension for a period of three continual months for medical reasons only. This must be done in writing with a medical certificate and cannot cross over two membership years. During a period of suspended membership, all membership privileges are suspended.
